CONDUCT RULES

- ✓ We have a **ZERO TOLERANCE** policy for any inappropriate behavior including but not limited to fighting, foul language, unsportsmanlike like behavior. The Site Coordinator has the right to disqualify a player from participation regardless if the referee/official does not.
- ✓ We encourage all people to reflect the character of Jesus by His grace.

PRE-GAME RULES

- ✓ NO RINGERS! This will be strictly enforced. A "ringer" is someone who is outside of the church and brought in for games because of their high skill level. All players must be part of that church for at least 6 months.
- ✓ Maximum 2 teams per church.
- ✓ Teams consist of max 10 players and a minimum of 5 players.
- ✓ Only Junior High and Senior High students may participate in games.
- ✓ Junior High teams will compete within the Junior High league, and not with the Senior High.
- ✓ Each Team without an adult leader (18+ years) must forfeit their game.
- ✓ **GAMES MUST BEGIN ON TIME!** Teams will lose playing time. 2 technical free throws will be given to the punctual team every 5 minutes.

SET-UP PROCEDURES

- ✓ Important Equipment: (if any are missing we will provide back-ups with a fee)
 - Game schedules
 - Practice Basketballs
 - Same color uniforms (t-shirts, or jerseys)
 - Numbered uniforms (Printed, Stickers, or Written Clearly on BOTH SIDES)

PRE GAME RESPONSIBILITIES

- ✓ Make sure stat sheets are filled in with player name and jersey numbers.
- ✓ Once the warm up time is over, both teams huddle at mid court to pray.
- ✓ Secure the benches. Only **Pastors**, **Coaches**, and **Players** are allowed on the benches.

GAME RESPONSIBILITIES

- ✓ All substitutions must check in with the scorekeeper.
- ✓ Injuries and/or **medical emergencies** are to be dealt with by the respective coach/youth pastor/parents. Please assist them in any way you can.
- ✓ Teams & Coaches should have read the games rules and abide by them.

POST GAME RESPONSIBILITIES

✓ Make sure teams clean the bench area of all trash and personal belongings.

NYYMN Basketball Tournament '16 **GAME RULES**

<u>In-Game Rules</u>

Time:

- ✓ Game Length: 24 minutes (12 minute halves)
- ✓ Game Clock: First half is running clock. Second half the game clock will stop for all whistles (out-of-bound, foul shots, etc.) in the LAST TWO (2) minutes.
- ✓ Shot Clock: 24 seconds
- ✓ Halftime break: 3 minutes
- ✓ Overtime: 3 minutes in Playoff Games
- ✓ Overtime Game Clock: The game clock will stop for all whistles in last minute only.
- ✓ Overtime Timeouts: 1 30 second timeout
- ✓ Draw: Games end in ties during League Play

Timeouts:

- ✓ Timeouts: 3 in total (can be used during the whole game) only teams possessing the ball can call timeouts
- ✓ Timeout Length: 30 seconds ✓ Injury Timeout Length: 1 minute

Players:

- ✓ Players cannot be on more than one team.
- ✓ Players must be on the registered on the team roster.

Substitutions:

✓ Substitutions: Players must crouch near the scorers' table before a substitution can be made. Wait for the referees queue.

Fouls and Free Throws:

- ✓ Fouls: Fouled out at 5 (if there are only 5 players and one gets fouled out, the fouled out person stays in but the other team gets a free throw and possession)
- ✓ Back court violation: loss of possession (Back court line is the free throw line at the opposing end)
- ✓ 3 second violation: turnover given when standing in the paint for over 3 seconds
- ✓ Team Fouls: 5 team fouls the opposing team will shoot 1&1; 8 team fouls = double bonus
- ✓ Free Throws: 2 given when in the act of shooting

Conduct:

- ✓ Proper Conduct: Foul language/Cursing will result in a technical foul and loss of possession.
- ✓ Spectators must stay off the court! A warning will be issued for the first offense, technical fouls will be issued thereafter to the church members team.

Playoffs:

✓ Playoffs are determined first by record, then by the amount of points scored (NOT point differential)
